Retest Policy

a) Re-Test Policy Students are permitted to re-take a failed examination or an unsuccessful lab exercise or practical demonstrations no more than twice. For written examinations, a new test will be given that does not contain any questions that appeared on previous examinations, quizzes, or homework given to the student. A student that fails an examination or cannot successfully complete an exercise or demonstration after three attempts will be required to re-take the entire course.

<u>b</u> If an applicant for an upper level officer endorsement as defined in NVIC 03-14 fails the exam, a complete re-examination must be administered. At least 2 hours must lapse for studying before another complete examination is attempted.
